Appendix 1

Terms of payment, established at the General Members' Meeting of 23-08-2013

- Payment term invoice membership fee: within 30 days after invoice date;
- Automatic collection is only possible for the main season with a membership fee of more than € 200 per member per season;
- In case of automatic collection, an authorization must be issued to the penningmeester;
- In the case of automatic collection 4% will be charged for administration costs;
- There are 10 collection terms from September to June. If a membership is started during the season, the terms that fall outside the season in question must be transcribed in advance;
- In the case of automatic collection in 10 terms, the collection amount is predetermined and cannot be changed;
- Term payments without automatic collection are not allowed.

Invoice of membership fee are due within 30 days after invoice date.

- 1st reminder: pay within 14 days;
- 2nd reminder: € 15, - administration costs, to be paid within 7 days;
- 3rd reminder: no more access to training and competitions;
- 4th reminder: claim is handed over to debt collection agency; the additional costs are entirely for members' account.

Automatic collection (see appendix 2):

- 10 installments annually from September to June;
- In case of reversal or failed collection: transfer within 7 days by yourself;
- For reminders after cancellation or failed collection, € 15, - administration costs will follow;
- In the event of a third cancellation or failed collection, the collection will be cancelled and the full membership fee must be paid within 14 days;
- If payment has not been made, participation in training sessions and competitions will be excluded until all claims have been paid.
- Debt collection agency: the claim is handed over and the ensuing costs are entirely at your expense.

If for any reason whatsoever it is not possible for you to pay on time, you must report this to the penningmeester before the expiry of the payment term:

In exceptional cases the board may decide to examine creative solution.
